DESCRIPTION OF PRELIMINARY SEARCH TO IDENTIFY NEED FOR SCOPING REVIEW

Background searching began Dec 2020 to identify Mesh Terms (Cochrane):

Mesh Terms identified in initial search:

- "Specialization"
- "Delivery of Health Care, Integrated"
- · "Community Health Services"
- "Child Health Services" "Maternal-Child Health Services"
- "Child, Preschool" and "Infant"

Title and abstract (tiab) terms were identified in January 2021 (see Table 1).

Reflective notes following intial searches: No date restrictions were applied to most seaches with the exception of OVID Medline (1991-current). Thoughts after a quick review of articles – how to approach? It might need to be about the model (see Wolfe et al. 2020).

27th Jan 2021 Definitions of integrated care:

Goodwin (2016, p.1) [1] includes two broad principles to 1) bring care delivery systems together, and 2) deliver optimal care that is centred around people's needs.

Wolfe et al. (2017) [2] present models based on an ecological systems perspective, and *cooperation* between professionals to deliver person-centred care. Cooperation between sectors can include between vertical care (primary care and secondary health care), horizontal care (health care and education), intersectorial care (health, education and social services), or longitudinal (health and non-health over time).

Hughes et al. (2020) [3] - an emerging set of clinical and policy practices shaped by context – 2 parts, the *methods* to organise, fund and deliver care, and the *goals* of outcomes and consumer experience.

N.B. – see Naik and Catic (2021, p.1) [4] "The concept of patient-centred care evolved into a model attuned to the patient experience of care, defined by the interactions between patients and providers and the care environment."

14th October 2021: 1843 Cochrane reviews, 133 Cochrane protocols.

Topic "Child Health" = 16 Protocols (none relevant),

= 541 Reviews

- Topic "Child Health Public Health" = 19 reviews none relevant
- Topic Child health Developmental, psychosocial and learning problems = 34 reviews - none relevant
- Topic Child health effective practice/health systems = 11 reviews none relevant

MeSH Search – "Delivery of health care, integrated" and "Child health" and "Effective practice/health systems" = 9 reviews and 5 protocols.

Reviewed abstract of one Protocol - Care co-ordination interventions to improve outcomes during pregnancy and early childhood (up to 5 years), 2017, DOI: 0.1002/14651858.CD012761. This relates to care co-ordination between separately funded services. This is a different perspective to our proposed scoping review.

CINAHL: "Health Care Delivery, Integrated" AND "Child Health Services" (MH Exact Subject Heading) 1991-2020, Academic journals, "all infant" and "child, preschool: 2-5"

14th Oct 2021: 79 results but no systematic or scoping review.
